

**MINUTES OF THE EVALUATION COMMITTEE
for the selection of n. 2 INCOMING MOBILITY POSITIONS FOR TRAINEESHIP AT SIENA JAZZ
ACADEMY FOR INTERNATIONALIZATION, CULTURAL EXCHANGE, AND GLOBAL
NETWORKING FOR THE ACADEMIC YEAR 2025/2026 – JAZZABLE PROJECT**

On October 8, 2025, at 12:30 PM, the Evaluation Committee met online regarding the selection notice for the assignment, in the Academic Year 2025/2026, of N. 2 participants for incoming mobility for traineeship activities to be carried out at Siena Jazz within the framework of the *JazzAble* project activities.

The mobility opportunities (long-term) are aimed at students under 30 years of age, holding a diploma and/or with previous experience in the musical field or at academic and cultural institutions, both Italian and international.

The mobility grants fall within the educational activities of the *JazzAble* Project, funded by the European Union, Next Generation EU, under the National Recovery and Resilience Plan (PNRR), Mission 4 – Component 1 “Enhancement of education services: from nurseries to universities” – Investment 3.4 “Higher education and advanced university skills,” sub-investment T5 “Strategic partnerships/initiatives to innovate the international dimension of the AFAM system, D.D. n. 124 of July 19, 2023, and subsequent amendments – Project INTAFAM_00078, Project Title JazzAble, CUP C61I24000070006.

The Evaluation Committee is constituted, following the appointment of September 19, 2025, as per the selection notice, composed of:

- Chairperson, Silvia Bolognesi, Professor at Siena Jazz;
- Secretary, Francesco Fiorenzani, Erasmus+ Coordinator of Siena Jazz;
- Committee Member, Lucia Piazzolla, Head of the International Relations and Erasmus+ Office of Siena Jazz.

Acknowledging:

- that the deadline for the submission of applications for the selection of N. 2 students to be admitted to incoming mobility for traineeship activities at Siena Jazz within the *JazzAble* project for the Academic Year 2025/2026 expired on October 1, 2025;
- that the applications submitted are formally complete and correct;

After verifying the formal correctness of the preliminary selection procedures, the Evaluation Committee notes that N.2 applications have been received. The Committee then proceeds to analyze the curricula vitae and experiences presented by the candidates. A brief discussion on the content of the CVs and the evaluation of the declared previous experiences is held, verifying their suitability for the type of activity envisaged.

At the end of the evaluation, the Committee reaches a unanimous agreement and proceeds to formulate the eligibility ranking:


