THE ARTISTIC AND EDUCATIONAL DIRECTOR

- CONSIDERING the validity of the selection notice issued for n.2 incoming mobility traineeships at Siena Jazz Academy, aimed at fostering the development of professional skills in the field of cultural cooperation and internationalization within the educational activities of the *JazzAble* project (Project Code INTAFAM_00078, CUP C61I24000070006), funded by the European Union, Next Generation EU, under the National Recovery and Resilience Plan (NRRP), Mission 4 – Component 1 “Enhancement of the education system: from early childhood to university” – Investment 3.4 “Advanced university education and skills”, sub-investment T5 “Strategic partnerships/initiatives to innovate the international dimension of the AFAM system”, Ministerial Decree No. 124 of 19 July 2023 and subsequent amendments;
- CONSIDERING the establishment of an Evaluation Committee, as required by the selection notice, composed of President, Prof. Silvia Bolognesi Teacher at Siena Jazz Academy; Recording Secretary Prof. Francesco Fiorenzani, Teacher at Siena Jazz Academy; Committee Member Dr. Lucia Piazzolla International Relations and Erasmus+ Office, Siena Jazz;
- CONSIDERING that the deadline for applications expired on 01/10/2025 and that all applications received within this deadline were complete and formally correct;
- CONSIDERING the proper conduct of the Committee’s work, which, during the meeting of 8th October 2025, evaluated the CVs and the candidates’ prior experience and drafted the corresponding assessment report;
- CONSIDERING that the President of the Evaluation Committee has definitively approved the eligibility/non-eligibility ranking of the candidates, which will be published on the official Siena Jazz website;
- CONSIDERING the resolution of the Siena Jazz Board of Directors dated 24/01/2025 authorizing the General and Administrative Director to implement the procedures for the identification and acquisition of goods and services (individual assignments/contracts up to a maximum of €20,000) necessary for the execution of the *JazzAble* project, in accordance with the project’s activity plan and budget;

HEREBY DECREES

the approval of the following eligibility/non-eligibility ranking for the selection of students under 30 years of age, holding a diploma and/or with previous experience in the musical field or within academic or cultural institutions, either Italian or international, for long-term incoming mobility traineeships aimed at fostering the development of professional skills in the field of cultural cooperation and internationalization, as part of the educational activities of the *JazzAble* project.
